**I/we the undersigned**, do hereby acknowledge and fully understands that Aqua Island is a strenuous outdoor physical activity that requires strength, stamina, fitness and the ability to swim. The runways and obstacles of the course are all inflatable items anchored in place and floating on the water surface. As such them obstacles are slippery and form an unstable but fun platform.

**I/We, the undersigned, further understands that injuries can, and do, occur.**

In using the Aqua Park, we acknowledge, understand and accept this risk of injury to myself, my friends and families. Anyone with **heart or health problems**, any **pre-existing injuries**, especially **knees, ankles, shoulders, spine, back and neck**, as well as **pregnant women** are not permitted on the park unless assessed by staff and undertaken a special safety briefing for that condition that includes exclusion from some obstacles.

**I/we, the undersigned understands that we will only use Aqua Island on the following conditions:**

1. Will follow all the safety rules listed below & advised by staff at the safety briefing & as required;
  2. Will always wear a **BOUYANCY VEST ALWAYS** & it must fit securely with the straps tightened.
  3. NEVER, under any circumstances, **swim underneath** any of the obstacles. ALWAYS go over the top.
  4. NEVER **DIVE HEAD FIRST** into the water from any part of the course. Always enter the water feet first.
  5. **ALWAYS look up whilst climbing. Do not climb underneath someone climbing above you.**
  6. Will make sure the water and landing area is clear of all people before jumping or sliding into the water.
  7. Will not slide down any area that has climbing handles attached.
  8. Will not participate in excessively rough play. I/we will be careful around smaller children and always give them right of way.
  9. Will tread carefully and show caution as the park is slippery and unstable.
  10. Will only use the park when lifeguards are on duty.
  11. Will never be used under the influence of alcohol, medication or drugs.
  12. Will always follow the directions of the lifeguards on duty
  13. Guardians of children between **3 and 7 years** old must within an **arms reach** of their children at **all times** & guardians of children **8 to 14** must **supervise** their children at all times. **1 guardian can supervise 3 children under 7 on the park.**
  14. I/we agree I/we have voluntarily chosen to participate in the activities at Aqua Island and hereby personally and freely assume all risks in connection with these activities, for any injury, death or damage.
  15. That I/we agree to accept those risks and all liability for the consequences of my actions.
  16. That I/we agree that will not make any claim for personal injury, death or damage or other loss and that I indemnity Aqua Island for any liability occurring as a result of or in connection with my participation in the activities at Aqua Island.
  17. I/we grant Aqua Island the right to use my image and name for media and marketing. (cross out if you don't agree)
  18. I/we will observe all Covid safe conditions of entry, practice social distancing & good hygiene practices.
